Agenda Item: Marty Cook/Recovery Connection

Marty Cook reported that the Recovery Connection continues to see strong support for their meetings from partnerships with Holy Family Hospital, Maryville Academy and Behavioral Hospital. The newly added Saturday AA meeting at the First Step House followed by their latest partnership with CrossFit in Park Ridge. He stated that they are providing not only physical activities but also mental support. These events maintain sobriety, build community among those in recovery and strive to give back to the greater Maine Township community. The Recovery Connection participants have been volunteering in the Maine Township Food Pantry since late November.

Marty Cook stated that Mark Sanders, an author, leading authority and historian on addiction referred to the Maine Township Recovery Connection program as "the model Community Recovery program". By Mark Sanders recommendation, Kellie Gage the manager of Adolescent/youth services for the Illinois Department of Human Services, Division of Alcoholism and Substance Abuse came on a recent Saturday to meet with a few of Recovery Connection participants to learn how to better outreach to that age who are taking the brunt of the opioid crisis in our country.

Agenda Item: Officials' Reports

Assessor Moylan Krey presented the proposed budget for 2018-2019 for the Assessor's office. She added that the Assessor is required to prepare and present a budget for the assessor's office to the township board at least 60 days prior to the beginning of each fiscal year. She wished everyone a Happy New Year.

Highway Commissioner Kazmierczak reported that Aqua stopped their major project on Washington Street due to the cold weather. In result they had to refurbish the work they already had done and did a good job. He added that the last snow fall was handled by the Highway Department and they received an acknowledgment from Westview Association in unincorporated Glenview for the good job done plowing.

Supervisor Morask inquired about the water main break on Emerson. Highway Commissioner Kazmierczak stated that it was not a major water break but the Highway Department provided barricades and salt.

Clerk Gialamas wished everyone a happy and healthy 2018 and introduced and thanked Officer Richards from Park Ridge Police Department for attending our meeting.

Trustee Sweeney reported that in the past month Trustees spent a lot of time going over budgets, levies and income statements insuring that tax payers' money is spent wisely.

Trustee Sweeney stated that going along with transparency she has researched the technology available for videotaping, recording and livestreaming from other organizations other than Granicus. She thanked Richard Lyon for videotaping and indexing which helps our residents to watch the meetings. Trustee Sweeney added that she is excited that Board meetings will be livestreamed soon and hopefully can be done in house.

Trustee McKenzie stated that it's been an informational couple of weeks going through all of the Agency Funding and learning the process of awarding the grants. She was pleased to see how closely the amounts were suggested and proposed by the Elected Officials and requested by the agencies.

Trustee Carrabotta stated that he agrees with other Trustees reports and added that on Monday, December 4th he was invited by Mariyana Spyropoulos, President of the Metropolitan Water Reclamation District to participate in the stage one of the water deep tunnel project. He congratulated Ms. Spyropoulos for this accomplishment which will keep water out of area basements.

Trustee Carrabotta stated that on Friday, December 8th he attended the MaineStreamers Holiday Luncheon with a wonderful turnout. On Tuesday, December 19th he attended the Special Board meeting and stopped by for Township Holiday luncheon on Friday, December 22nd.

Trustee Jones stated that she attended the last Neighborhood Watch meeting on Wednesday, December 6th and the Special Board meeting regarding Tax Levies approval on Tuesday, December 19th. Supervisor Morask stated that she will give her report at the end of the meeting.

Supervisor Morask explained that even though the Maine-Niles Association of Special Recreation applied for Agency Funding, they could get more funding from Maine Township through the Reilly-Bialczak scholarship.
