Supervisor Morask called the meeting to order at 7:01 p.m., Clerk Gialamas led the Pledge of Allegiance and called the roll.

Agenda Item: Public Participation

Doriene Prorak stated that she is a Park Ridge resident and works for Maine Township. She began by stating that neither Supervisor Morask nor any of her co-workers were aware that she was going to speak this evening. Ms. Prorak stated that based on comments made at the January 23rd Board meeting, she suspected that a majority of the Board may vote to stay in open session to discuss employee performance evaluations and raises.

Ms. Prorak pointed out that she would be very uncomfortable listening to her co-workers evaluations. She strongly felt that this subject should not be anyones business except the Board and the Administration. She stated that in her opinion, performance evaluations and compensations discussion are of personal and confidential nature and should be limited to closed session only.

Ms. Prorak respectfully requested that the Board vote to move into closed session to discuss Maine Township staff's evaluations and compensations.

Supervisor Morask asked for a motion to go to the Closed Session under Section 5 ILCS 120/2 (c)(1) for the sole purpose of discussion of performance and compensation of specific employees of Maine Township. She added that there would be no action taken in the closed session.

Trustee Carrabotta thanked Attorney Dowd for the clarification explaining that the closed session is not mandatory for the discussion of employee salaries and potential raises.

Supervisor Morask emphasized that due to the personal records protection act and the privacy of the employee performance evaluations she recommended to have these discussions in the closed session. She elaborated on the process of employee evaluations and added that at this time only six specific employee's evaluations will be discussed.

Trustee McKenzie inquired about employee's salaries not being in the board packet.

Supervisor Morask explained that the spreadsheet with salaries was available. As tonight's meeting contemplated only discussion, and no action, of the first two sets of department recommendations, a full spreadsheet would be provided prior to any decision making. A further question was raised by a

Trustee as to the effect on the budget. Supervisor Morask cautioned that there was a PAC opinion that she was distributing that held that budget discussions (or effect on the budget of proposed increases) could not be discussed in closed session simultaneously with discussion of performance evaluations and potential raises for specific employees. Supervisor Morask stated the PAC opinion was being copied to distribute to them tonight.

Following the Trustees questions and comments regarding said procedure, it was decided to call a vote.
