Supervisor Morask called the meeting to order at 7:02 p.m., Clerk Gialamas led the Pledge of Allegiance and called the roll.

Agenda Item: Public Participation None.

Agenda Item: Appointing a Maine Township Attorney

Supervisor Morask stated that Maine Township attorney Dan Dowd resigned on March 24, 2018 and the Board is in need to appoint a new Township Attorney.

Supervisor Morask stated that the Board received Ancel Glink, P.C. background and proposal for legal services prior to the meeting for their inspection.

Supervisor Morask stated that she had chosen the Ancel Glink firm with representation by Jeff Brown, Keri-Lyn Krafthefer and Kurt Asprooth since that firm represents numerous Illinois entities including townships for over 80 years and they had been hired to redo our personnel Manual and had done a fantastic at a very competitive price as well as handled other personnel township issues extremely well. She pointed out that Keri-Lyn Krafthefer co-authored the "Township Officials of Illinois Laws & Duties Handbook" and she is redoing our Township's Personnel Manual Policy. Jeff Brown wrote numerous articles regarding Township's Law and will be coming to the Board meetings and Keri-Lyn Krafthefer will be a name partner.

Highway Commissioner Kazmierczak stated that he had used Jeff Brown's legal services many times and he did a good job.

Supervisor Morask then requested a motion for hire of the Ancel Glink attorneys asking for a motion to hire. There was no motion. Prior to any motion or second, Trustee Sweeney requested a motion. See video at the 6:00 min. mark.

Trustee Sweeney said she was not part of this process. Much later in the board meeting, Supervisor Morask said that she misspoke regarding doing an RFP.

Trustee Sweeney again asked Supervisor Morask for consideration under Robert's rules to call the vote that was motioned and seconded as it was before any attorney hire motion or second.
