Trustee Sweeney: I did have an interview. I just didn't have a court reporter.

Trustee Jones: But you were the only one who weren't deposed with a court reporter.

Trustee Sweeney: At the time I didn't know was

Trustee Jones: I'm just wondering what was your objection to testifying in front of a court reporter when everybody else wasn't afforded that privilege or right so why

Trustee Sweeney: I didn't view it as a privilege or a right. Anybody could have made their own choice. I didn't know what everybody was doing so ... I just had an individual interview with them and chose to give them the information.

Trustee Jones: Actually, one of the employees asked to remain anonymous and they weren't given that right so what your saying it is not accurate for the record it's not accurate.

Trustee Sweeney: I cannot comment on the legal opinion given to somebody else, Trustee Jones. I can only comment on what I did. Thank you.

Trustee Jones: But you still did not answer the question. What was your objection to testifying in front of a court reporter?

Trustee Sweeney: I just chose to interview without that. Trustee Jones: Why? That's the question. Trustee Sweeney: That was my choice.

Agenda Item: Personnel, Open Maintenance Position Update/Department Director Report; Mike Samaan Michael Samaan, Maintenance Director reported that the mold removal and the water proofing project are complete.

Mr. Samaan stated that the Township passed the backflow prevention test, fire detectors and he is working on the elevator to be passed. He is also working on replacing batteries and light bulbs for township's exits signs and emergency lights. The garage sale on Saturday, September 29th and the busy season with food pickups for food pantry are coming up soon. He added that he is looking for hiring a painting company to paint the Town Hall and the money will be used from the Capital Fund.

Mr. Samaan presented a resume of Steven Basista, who he recommended for the open part-time maintenance position. He added that Supervisor Morask, Administrator Berman and he interviewed a total of three people and felt Mr. Basista is the best candidate to his team. Mr. Basista lives in the unincorporated area of the township and has a background in maintenance and repair.

Agenda Item: Officials' Reports

Assessor Moylan Krey stated that the "Property after Death" seminar on September 13th was a huge success and well received. Last week her office assisted residents finding the legal owners of the people at the Landings after a devastating fire. The owners were found in the Cook County Recorder of Deeds and the list of these residents were given to our General Assistance office and Food Pantry.

Assessor Moylan Krey reported that her office helped residents to obtain from doing certificate of errors for \$516,952.70. These residents will be receiving a check from Cook County Assessor in about 3-6 months.

Highway Commissioner Kazmierczak stated that auction company is coming up to the Highway Department to take pictures of equipment that will be put up for an auction. He reported that the curb and sidewalks project is finished on Dee Road, Stacy, Julie and Pauline. He added that Stacy, Julie and Pauline Streets will be resurfaced with the budgeted funds and Dee Road and Kathy Lane will be postponed to the next year.

Highway Commissioner Kazmierczak stated that his department provided barricades for the police during the tragic fire at the Landings.

Supervisor Morask thanked Mike Samaan and Nader Ghazaleh for saving the Township thousands of dollars on a concrete contract. She also thanked Mr. Ghazaleh for catching the driver at 6:30 a.m. and for issuing a citation for parking a commercial vehicle and spewing garbage on Dee Road at night. She added that Sharon McLaughlin sent us pictures from different areas on Sumac and Robin and Mr. Samaan and Mr. Ghazaleh went there immediately and cleaned up the area. Supervisor Morask noted that Republic Services agreed to change their routes for better assistance.

Supervisor Morask thanked everyone in the Township who helped the victims of the Landings' fire. She started the communication with OEM, Highway Department, Maintenance, General Assistance office and Administrator Berman. Supervisor Morask stated that we were able to help many victims. The emergency boxes were made with food, toiletries, clothes and other needed items. General Assistance office helped these residents with those boxes and also with looking for housing or other assistance. She added that boxes for donations are displayed in the hallway.

Supervisor Morask noted that Center of Concern is having a dinner reception on October 12th and she will be accepting an award honoring Maine Township. She announced the upcoming TOI Conference and stated that TOI participants should contact Doriene Prorak .

Supervisor Morask noted that food supplies were delivered to our Food Pantry for the Landings' fire victims by the Mission Greenline, Inc. in Glenview.

Trustee Jones expressed her condolences to the family of the fire victim and to residents that were displaced from the fire. She thanked OEM and Dagmar Rutzen for helping at the Landings.

Trustee Jones stated that she attended the Open House at North Maine Fire Department along with Highway Commissioner Kazmierczak, OEM, Doriene Prorak, Mike Samaan, Dick Barton and Alex Barton. She also, attended the Cubs game with MaineStreamers, Highway Commissioner Kazmierczak and Assessor Moylan Krey. She was helping with the Food Pantry to help the fire victims and added that everybody was on their game with helping.

Trustee McKenzie extended her condolences and heartfelt thoughts for families from the Landings. She added that she is proud of the Township for providing quick and a necessary response which is a testament to the kind and quality services we provide. Trustee Carrabotta stated that he was out of town but immediately was notified by the Township about the Landings fire. Great job as usual with the Township's staff. He asked for a prayer for that special woman who lost her life and for all the families suffering their losses.

Trustee Carrabotta talked about his experience of patriotism, exceptionalism and sacrifice for fellow men by wonderful Naval personnel who provided him with the tour of the Naval Base in Pensacola, Florida. He thanked his host for their hospitality.

Trustee Carrabotta stated that he attended 65th anniversary at Saint John Brebeuf parish at Niles and mentioned the Center of Concern dinner/gala will be also a wonderful event to attend.

He thanked the residents who came to the Board meeting which shows commitment to Maine Township and our community.

Trustee Sweeney also extended her condolences and prayers to the families from Landings' fire.

Trustee Sweeney stated that she was impressed by the work and quick response from the Township the day after the fire with the process to help these residents.

Trustee Sweeney stated that she is trying to familiarize herself with all the records kept in Maine Township.
