Supervisor Morask stated that by December 9th, the Board of Trustees has to determine the estimated property Tax Levy for Town Fund/GA and Highway Department to comply with the Truth in Taxation law.

Administrator Berman stated that the proposed draft of the 2020 Tax Levy for Town Fund and General Assistance was included in the board distribution. She added that the levy enclosed has a \$537,922.00 decrease in Town Fund and a \$206,822.00 decrease in General Assistance for a total decrease of \$744,744.00 from the 2019 levy on file. She suggested using these numbers as the estimated 2020 Tax Levy.
