Supervisor Dimond called the meeting to order at 6:45 p.m., led the Pledge of Allegiance and Chief Deputy Clerk Tytko called the roll.

Agenda Item: Public Participation

Agenda Item: Discussion on the status of the Office of Emergency Management (OEM) See video at 3:19.

Supervisor Dimond stated that recently the Maine Township Office of Emergency Management was suspended.

North Maine Fire Protection District Chief Michael Bronk stated that he has been employee of the Fire Protection District since 1977. He talked about Fire District being a liaison with the Maine Township Office of Emergency Management (OEM) for many years. Chief Bronk pointed out that for many reasons there is a need for OEM in the Maine Township. He stated that there is even a possibility to expand this program to the high school and junior college level students. Also, he added that resources are available and there are people that are willing to volunteer.

Discussion.

The Board members had some questions to Chief Bronk on qualifications needed for that position. Supervisor Dimond thanked Chief Bronk.

Agenda Item: Discussion of Rebranding of Township Logo/Color/General Theme

Supervisor Dimond stated that Trustee Horvath was working on the Rebranding of Township/Logo/General Theme project quite a bit and asked her for an update.

Trustee Horvath stated that after the last Board Meeting, she had a discussion with Robert Flinn and Marty McAlpin and she came up with simpler options with a proper size and versatility. She presented 3 options for Maine Township logo.

Robert Flinn commented on the suggested logo.

Discussion and comments.

Supervisor Dimond and Trustees agreed on option 2, with the font from option 1 and to use it only for the social media.

Supervisor Dimond thanked Trustee Horvath and said that the Board appreciates her work.

Robert Flinn was very excited to share that the launching of a new Mainely E-News and the Maine Township advertisements that will take place later this month in the social media. He pointed out the importance of targeting our community through Facebook and YouTube. The cost of advertising on Facebook and YouTube will be \$1,000 each depends on a type of an add.

Agenda Item: Discussion and Possible Vote Regarding Employee Salaries

Supervisor Dimond stated that a few Board members requested a discussion on employees' salaries. Trustee Maher stated that he reviewed the Salary Study done in May 2019 for Maine Township

employees. He evaluated and came to the conclusion that 60% of Maine Township employees are below average market rate.

Trustee Horvath was curious to know if there were additional raises since that study came out.

Supervisor Dimond stated that a year ago there was 3% increase, prior to that 1.2% and year before nothing consistent across the board.

Trustee Jones stated that last Board was very adamant and they wanted to keep all salaries down. She added that many people left for various reasons and they were not replaced. Many employees have double duties with same salary.

Highway Commissioner Beauvais pointed out that Maine Township staff does a very good job and should be compensated for that.

Assessor Moylan Krey agreed that with more responsibilities and a constant education to new systems good workers should be paid more.

Trustee Malik agreed with increasing salaries for employees.

Supervisor Dimond stated that salary increase is needed and suggested it for employees that held their position for at least one year.
