Catherine Sbarra, CEO & Senior Benefits/Facility Advisor from National Group Health Alliance LLC, gave a presentation regarding benefits renewal for the Maine Township 2022 medical, dental, life and vision insurance. She explained the negotiated rates from BlueCross BlueShield, Humana and United Healthcare and the options for the PPO and HMO Grandfathered Rates. Ms. Sbarra mentioned that our pretty high active claims are over \$500,000. Ms. Sbarra recommended staying with the Grandfather Plan of BlueCross BlueShield of Illinois with the final rate increase of 4.65%.

Ms. Sbarra stated that Principal Life Insurance Co. gave us a final rate increase of 2.5% on dental and a rate pass on employer paid voluntary life. Vision with VSP gave us the requested pass and a 4 year guarantee that no rates will change until 2026.

There were numerous questions and a discussion.

Supervisor Dimond stated that voting on this matter will be during the next Board Meeting.

Supervisor Dimond thanked Ms. Sbarra for her presentation.

Mr. Rojas stated that he is an experienced educator, safety and security supervisor and medical technician. She thanked Marie Dachniwsky and her staff for making calls and checking on people who are signed up for the workshop if they are attending because of the waiting list. Some political officials are going to be there including Maine Township Supervisor Dimond and Trustee Jones, Senator Laura Murphy, State Representative Marty Moylan and Mayor Andrew Goczkowski from Des Plaines. She said that as of April 24th, the Assessor's Department is done with appeals for the Board of Review. Assessor Moylan Krey said that she was at the Board of Review Reach Out event at the Des Plaines Library. She mentioned that because of redistricting from the census Maine Township has a new Commissioner Michael Cabonargi.

Supervisor Dimond announced that on May 11th, the Free Electronics Recycling and Drug Takeback Event is going to take place in the Maine Township's parking lot. Secretary of State Mobile Unit with a representative from the Illinois Treasurer I-Cash program is going to be here on June 15th and the North Suburban Legal Aid Society presentation is rescheduled on June 23rd.

Supervisor Dimond said that soon we are going to start our garden along South wall of the Maine Township's building.

Supervisor Dimond mentioned last month's happenings and events that she attended, and said that it was a very active month. Supervisor Dimond stated that we have gotten invitations from Village of Niles and City of Des Plaines to march in the Fourth of July parades.
