Maine Township's resident Audrey Nankervis came along with two other neighbors asking the Board members for help solving a problem with the internet connection. She stated that this morning Flood Brothers' garbage truck hit the pole and pulled the cable line down which caused no phone, no cable and Wi-Fi connection. She spent the whole day calling Comcast, Fire Department and Maine Township. Code Enforcement Nader Ghazaleh stated that he made some calls to find out who owns that pole but there is a lack of communication.

Discussion and comments.

Supervisor Dimond asked Nader Ghazaleh and Commissioner Beauvais to continue to look into this and keep her posted.

Commissioner Beauvais stated that he will send somebody to determine who the pole belongs to.

Trustee Maher suggested to complain directly to the cable company and tell them to fix it because it is their responsibility.

Agenda Item: Old Business, Discussion and Vote on the Renewal of Employee Insurance Benefits See video at 11:40

Supervisor Dimond stated that at the last Board Meeting Catherine Sbarra, CEO & Senior Benefits/Facility Advisor from National Group Health Alliance LLC gave us information regarding benefits renewal for the Maine Township 2022 medical, dental, life and vision insurance which is up on July 1st and asked Ms. Sbarra for quick recap.

Ms. Sbarra stated that the best decision for the Maine Township will be staying with the Grandfather Plan for the PPO and HMO of BlueCross BlueShield of Illinois with the final rate increase of 4.65%. Ms. Sbarra stated that Principal Life Insurance Co. gave us a final rate increase of 2.5% on dental and a rate pass on employer paid voluntary life. Vision with VSP gave us the requested pass and a 4 year guarantee that no rates will change until 2026.

Agenda Item: Officials' Reports, Summer Parades See video at 46:32

Supervisor Dimond informed that several communities invited us to be in their parade: Park Ridge-American Legion's Memorial Day parade on Monday, May 30th, at 10:00 a.m., Niles and Des Plaines Fourth of July parades. Supervisor asked the Board members for participation.

Commissioner Beauvais stated that he signed up the Highway Department for the Des Plaines and Niles parades. Trustee Jones, Truste Malik and Trustee Maher said that they will attend the Park Ridge Memorial Day parade.

Supervisor Dimond announced that Secretary of State Mobile Unit is going to be here on June 15th, Community Wellness Fair will take place on June 16th, registration required, and The North Suburban Legal Aid Society presentation is scheduled on June 23rd. Dumpster Days during which Maine Township residents can get rid of unwanted large items will be happening on June 22nd thru 25th. She said that Cyber Crimes & Cyber Safety Presentation is organized by Marie Dachniwsky, along with the Sheriff of Cook County on July 7th.

Supervisor Dimond mentioned that National Night Out is planned on August 2nd and she asked Clerk Gialamas to talk about that event.

Clerk Gialamas stated that the Maine Township will be hosting the National Night Out along with the Golf Maine Park District, Cook County Sheriff's Police and North Maine Fire Department. He said that five to six hundred local residents are expected to come. It is going to be a great event with lots of entertainment. He extended an invitation to those who would like to come to the next planning meeting on June 27th. Clerk Gialamas announced that there is a poster contest for all the local kids from the different summer camps. Poster's theme is "Turn Your Lights on and Turn Crime off" and the poster judging will be on July 18th. Everything will take place at the Dee Park.

Supervisor Dimond said that on August 9th we will have a Cook County Sheriff's Self-Defense Class.

Supervisor Dimond brought to everyone's attention that a couple of flyers are about the Food Pantry programs and one of them is new called "Maine Township's Summer Weekend Go-Bag for Kids", a program that provides kids with needed food for the weekend. Supervisor Dimond mentioned that the Maine Township Garden is now in and hopefully will generate some food for our Food Pantry.

Agenda Item: Officials' Reports, Discussion of Summer Festivals

Supervisor Dimond asked Trustee Malik to talk about Summer Festivals.

Trustee Malik stated that two months ago the Board members decided that the Indian Culture Festival will take place on August 13th and the Pakistani Festival on August 14th. The reason to have both festivals during one weekend is to lower the costs of organization.

Supervisor Dimond stated that all departments have to help with organization of the festivals and also told Trustee Malik that maybe he will have to hire people to perform some of the services.

Trustee Horvath stated that our next Board meeting on Tuesday, June 28th is Election Day and she will work that day as an election judge and she will not attend the Board meeting.

Supervisor Dimond proposed to move the Board meeting from Tuesday, June 28th to June 29th and all the Board members agreed. She asked Chief Deputy Clerk Magnowski to send a Legal Notice regarding rescheduled Board meeting to the newspaper.

Trustee Maher attended a mentoring program administrated by Richard Lyon and it is sponsored through The Big Sisters and Big Brothers United Way.

Trustee Horvath mentioned that on Saturday, June 4 from 3 to 7 p.m., a community pride celebration organized by the Maine West LGBTQ student group will take place at Maine West H.S. and Mainstay is going to be there with a new pride program supporting LGBTQ youth.

Trustee Jones announced that the next Neighborhood Watch Meeting is canceled and it will resume in July.
