Dr. Philips stated that the church designed by Lloyd Wright, son of the famous architect Frank Lloyd Wright, in the ninety-sixties, and now owned by the Maine Township is historically and architecturally very significant in Park Ridge.

Supervisor Dimond stated that there are several dead trees around the property of Maine Township and we do need some landscaping work. She asked the Board members for an opinion if all the dead trees that they saw should be removed or just some of them.

Discussion and comments.

Clerk Gialamas stated that all the dead trees should be removed because at some point they will be a hazard.

Trustee Jones agreed and added that there are a lot of overgrowths and that the landscaping should be cleaned up.

Trustee Malik stated that the \$1450.00 contract with the landscaping company should be revised because the service is very poor.

More discussion and comments.

Administrator Dayna stated that she will ask the landscaping company for a more detailed description of the service that they are providing.

Supervisor Dimond stated that under New Business there is one more item that is not listed on agenda and asked Commissioner Beauvais to talk about it.

Highway Department Commissioner Beauvais stated that Supervisor Dimond and he discussed unpaid citations issued by Maine Township's Code Officer. He said that he looked into Municipal Collection Services and there are multiple options to collect debts. Commissioner Beauvais asked the Board officials for a discussion on this matter.

Discussion and comments.

Supervisor Dimond stated that more research can be done on this topic and it will be on the next Board meeting agenda.

Agenda Item: Officials' Reports, Announcement

Supervisor Dimond announced that at the last Closed Session during Board Meeting on August 23rd the Board members decided that minutes from October 22, 2019 #1, May 25, 2021, July 27, 2021, February 22, 2022, July 26, 2022, & August 23, 2022, will remain confidential.

Supervisor Dimond stated that the 16th Annual Maine Township Garage Sale fundraiser held on September 17th was a big success. The event organized by Mainestay generated a record-breaking total of \$5610.53, which is a 35% increase in revenue in 2019. Supervisor Dimond thanked everybody and congratulated all the staff members that worked on this event particularly Richard Lyon and Emily Toomey from Mainestay.

Supervisor Dimond stated that on September 19th, the Power of Attorney Seminar, which was held at Maine Township and run by the Mainstreamers was also very successful.

Supervisor Dimond said that all the improvements at the Food Pantry are completed and on September 22^{nd} , we had the Grand Reopening.

Supervisor Dimond reminded everyone that on October 18th, an Agency Funding Special Board Meeting is scheduled. She stated that on October 20th, Maine Township will host Township Officials of Cook County, Supervisors Division meeting. Supervisor Dimond announced that October 22nd will be a very busy day with two events: Document Shredding at Maine Township and Food Pantry at Park Ridge Farmer's Market.

Supervisor Dimond stated that on October 27th, North Suburban Legal Aid Clinic - Program on Services is scheduled, and is going to be virtual. She noted that Maine Township will be hosting a FLU/COVID Jewel-Osco vaccine booster clinic on October 28th at Town Hall. Supervisor Dimond reminded the Board about the Annual Educational Conference for the Township Officials of Illinois on November 13-15, 2022.

Trustee Horvath extended an invitation to everyone to attend a play at Maine East High School on September 29th, September 30th or October 1st.

Trustee Maher congratulated MaineStreamer's Director Dachniwsky on the outstanding events organized during last month.

Assessor Krey stated that Maine Township residents may file an appeal until October 7th. She stated that the appeal process in Maine Township will end on October 4th, because in the past there was difficulty sending appeals to Cook County Assessor's office since their system went down.
