Supervisor Dimond stated that the proposed 2022-23 budget that was distributed in the board packets has been \$100,000 higher than the tentative budget discussed in February. She noted that some changes have been done due to website redo, possible YouTube advertising, needed computers, adding funds to OEM, moving two part-time MaineStay therapists to full time position, adding possible part-time maintenance position, and increases in salaries. Supervisor Dimond stated that this year's budget is higher than the last year's.
