Highway Commissioner Beauvais stated that this amended budget was a collaborative effort involving Foreman, Pete Douvalakis, Administrator Dawne Hayman and himself. Administrator Hayman did the analysis of Highway Department spending for previous years to estimate numbers that would represent fiscal year when their costs were higher, as well as fiscal years when their costs were lower. They have included two graphs that note requested levy amount and actual levy amount received, as well as approved fiscal year budgets and actual budget numbers at the end of the fiscal years. He added that from December 2020 to December 2021 consumer prices for all item rose 7.0 percent which directly impacted the Highway Department's annual costs.
