Deputy Administrator Rizzo reminded the Board that Maine Township owns three black and white copiers, one color copier, eleven printers, and two multipurpose fax machines, and that the annual maintenance agreement is necessary to operate the devices. She stated that at the last meeting quotes from four vendors were presented and today she is presenting the revised quotes. Deputy Administrator Rizzo stated that after the research her recommendation is Pulse Technology with the cheapest and easiest to manage out with the quotes: \$700 per month, \$8,400 per year.

OEM Director Olewinski stated that Code Enforcement Ghazaleh and he are closely monitoring the Noel fire property. He said that they have proactively addressed fencing-related issues and provided assistance to expedite the demolition process. OEM Director Olewinski stated that to ensure transparency and awareness, both Code Enforcement Ghazaleh and he attended court meetings with Cook County to update the Township on the legal action proceedings and the status of the property on Noel where the explosion occurred.

MaineStay Director Lyon gave an update on Maine Township's Native Prairie Garden and he pointed out that after 15 years the Maine Township's Native Prairie Garden is a weed garden. MaineStay Director Lyon stated that in the past couple of weeks Supervisor Dimond, Maintenance Director Samaan and he met with an environmental science and biology teacher Shelby Riha from Maine East Highschool. Mr. Lyon said that Ms. Riha talked about how we will be able to partner with them plus she gave the ideas on how to restore the garden from the past. He pointed out that it would be a long process.

Supervisor Dimond stated that the dates for the Agency Funding Hearings need to be scheduled. After discussion, everyone was in favor of prescheduling said hearings for Tuesday, October 3<sup>rd</sup>, and Thursday, November 9<sup>th</sup>, starting at 6:30 p.m.

Agenda Item: New Business, Discussion and Possible Vote of Education & Training Reimbursement Program

Supervisor Dimond stated that in the board packet, the Board officials could find the Education & Training Reimbursement Policy that was in a previous Personnel Policy Manual. She stated that we have had several inquiries from staff wanting to take classes or courses that would enhance their positions here at the township. Supervisor Dimond pointed out that now we are paying for training such as workshops, seminars, and classes that employees need to take to do their current jobs. She stated that this provision used to provide tuition reimbursement for undergraduate or graduate degrees.

Supervisor Dimond asked the Board members for a discussion about whether they would be interested in reinstating this policy or a similar policy in our current PPM.

Comments from the Board officials who agreed that it would be a good idea to implement that program under some circumstances.

Supervisor Dimond thanked the Board for all the comments and asked the Board members for samples of the policy that they would be receptive to and stated that she would work on this matter.

## Agenda Item: New Business, Discussion of Maine Township Recovery Connection budget

and policy

Supervisor Dimond stated that in fairness to Maine Township taxpayers and to other Maine Township Departments, Recovery Connection clients had been asked to pay for their tickets when they attended comedy clubs or ballgames. However, if a participant lived in Maine Township and was indigent that participant would still get a free ticket. And all participants, regardless of whether they lived in Maine Township or were indigent, would continue to get a free dinner every night at the Recovery Connection meetings.

Supervisor Dimond stated that this requirement would be more consistent with requirements imposed on other Departments - such as General Assistance, Food Pantry, MaineStreamers, and MainStay -where all participants must (1) establish that they live in Maine Township and (2) pay the cost of the service they receive or establish that they are indigent and unable to pay. As an example, Supervisor Dimond pointed out the MainStreamers had to pay the cost of attending a Chicago Dogs ball game while the Recovery Connection was asking the township to send them all to the same game for free and that this was inconsistent and unfair.

Recovery Connection Director Cook stated that in 2015 the Maine Township Trustees implemented the Recovery Connection and every subsequent year they received 100% approval from all the Trustees and two past Supervisors were all supportive of the program. He talked about the importance of this program. Mr. Cook said that Supervisor Dimond cut the program without consulting it with the Board and he would like to hear from the Trustees if they agree with the decision. Recovery Connection Director Cook explained that the expenditures have decreased because of COVID all the programs were canceled. He pointed out that the baseball flyer is asking for a donation of \$25, and money is collected from the Recovery Connection clients, plus every meeting there is a donating box for food.

He stated that there is an old analogy that the cure for addiction is to build the community and this is what we are doing every Friday at the Maine Township, we are building the community. Mr. Cook said that we have been recognized throughout the State for this program. He stated that right now we are in the middle of the worst opioid crisis in the country.

Recovery Connection Director Cook pointed out that this is an anonymous program.

Many comments from the Board officials.

Clerk Gialamas stated that Recovery Connection is an investment in keeping these people sober and on the right path.

Trustee Maher stated that Recovery Connection is the most important department for rehabilitating adults with addiction problems. Trustee Maher said that Recovery Connection Director Cook has a better opinion of whether this program helps people fight addiction since Mr. Cook has been at the Maine Township for almost ten years and the Board officials have been here for only a few years. He pointed out that the Recovery Connection program is known everywhere with many awards.

Trustee Horvath stated that this is a very difficult and sensitive issue to discuss but we have to find some kind of balance. She said that we have to come up with a sort of guiding principle that we can honor all the different groups in the same way.

Trustee Malik stated that the Board is approving so much money for the Funding Agency program and we do not have proof that clients of these Agencies are Maine Township's residents. He mentioned that the salaries of the Agencies' directors are huge. Also, Trustee Malik said that every month the Board officials approve a lot of money for General Assistance.

Trustee Malik pointed out that Recovery Connection Director Cook is saving lives.

Highway Commissioner Beauvais stated that it is very valuable what Mr. Cook is doing.

Assessor Krey also stated that Recovery Connection is a great program.

Trustee Maher thanked Highway Commissioner Beauvais for his outstanding volunteers who worked really hard at the Beer Tent during the Taste of Park Ridge.

Trustee Malik extended his invitation to everybody for the India Festival on August 12<sup>th</sup>, and the Pakistan Festival on August 13th, at Dee Park from 3:00 p.m. until 9:30 p.m.

Clerk Gialamas announced that the Cook County Board of Commissioners passed an ordinance sunsetting the wheel tax after the 2022-2023 tax year.
