Agenda Item: Officials' Reports

Assessor Krey announced that they are finished with the property tax appeals for 2025.

She also reported that there is still no confirmed release date for the tax bills, but once they are issued, taxpayers will have 30 days to pay them. Because the tax bills are delayed, her office submitted a large number of certificates of error and sent out approximately 190 letters to affected residents.

Additionally, Assessor Krey reminded everyone about the Cook County Homeowner Relief Fund. She noted that residents are now eligible to apply if their tax increase was 30% or more, instead of the previous

50% threshold, making the program accessible to many more homeowners. Applications can be submitted until October 31.

Highway Commissioner Beauvais reported on the Church and Western project and expressed gratitude to everyone involved, especially his staff, Cook County, and all intergovernmental partners for helping move the project forward. The sidewalk is now installed, and crews are repairing driveways, fixing concrete, and adding new concrete as needed. Paving and striping at Church Street and Western will continue over the next two weeks, with the bike lane expected to be ready for winter. He will update the Board when all work is complete and hopes to celebrate the new bike lane on-site.

Clerk Gialamas noted that he attended the volunteer appreciation dinner we hosted for our Food Pantry volunteers, which was a wonderful opportunity to express our gratitude for their service. He added that, in the coming weeks, the Food Pantry will likely become even more essential to Maine Township residents, especially with SNAP benefits set to expire. Again, he thanked our volunteers, and also, Food Pantry Director Pitzaferro for running the department so well and so efficiently. Clerk Gialamas wished him all the best in the weeks ahead.

Trustee Lynch echoed Clerk Gialamas, noting an article in The Journal & Topics about staff preparing for the surge. She said community needs have already increased and thanked General Assistance and the Food Pantry for their efforts. Trustee Lynch also congratulated Richard Lyon on being named Director of the Year by the Association of Illinois Townships Committee on Youth.

Trustee Maher reported that he attended last month's Neighborhood Watch meeting, noting improved attendance. He also attended Marty Cook's event, which he described as outstanding, featuring a speaker with an inspiring story. Trustee Maher congratulated several departments, including Clerk Gialamas and his staff, whose office processed 1,399 passport applications last year, which is a remarkable achievement. He also praised MaineStreamers Director Dachniwsky and her team for raising a record \$6,468 at the Alzheimer's Walk. Additionally, he congratulated Richard Lyon and volunteer Art Mullenhauer on their recent awards.

Trustee Horvath reported attending several agency meetings last month, which she called her favorite of the year. She highlighted how valuable it is to see the wide range of organizations supporting the community, especially during challenging times. Trustee Horvath expressed excitement about the board's upcoming funding decisions.

Supervisor Jones confirmed Trustee Horvath's comments, noting that agency meetings are valuable because they relate to one of the township's mandated tasks in general assistance and health. Supervisor Jones reported a record week at the Food Pantry, with 300 families served and 21 new sign-ups today. She noted the township is monitoring national developments and will attend a Zoom session on SNAP. Supervisor Jones also noted that last Sunday, the Food Pantry Director Pitzaferro and she participated in the Crop Walk, which was very successful. It was a beautiful day with many participants, and a generous donation is expected from the event. Supervisor Jones mentioned that Administrator Rizzo, Chief Deputy Clerk Magnowski and she attended the TOCC Conference, which was informative and engaging. Additionally, Administrator Rizzo and she attended a ribbon-cutting in Niles yesterday for Magic Pepper, a new Indian restaurant. They sampled the food, which she described as wonderful, emphasizing the importance of supporting local businesses in Maine Township and Niles.

Supervisor Jones announced upcoming events: the Third Annual Trunk or Treat Night this Thursday, October 30<sup>th</sup>, the Neighborhood Watch meeting on November 5<sup>th</sup>, at 7 pm, with the Sheriff and Fire Department representatives, the Veterans Recognition Event on November 7<sup>th</sup>, Electronics Recycling on November 14<sup>th</sup>, and Trustee Malik's Annual Turkey Giveaway on November 22<sup>nd</sup>.
