

TAX LEVY ORDINANCE 2012

MAINE TOWNSHIP ROAD DISTRICT

ORDINANCE 2012 - RB 3

An ordinance levying taxes for all road purposes for the Maine Township Road District Cook County, Illinois, for the tax year 2012, collectable in 2013.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, as follows:

SECTION 1: That the Highway Commissioner of the Maine Township Road District on November 27, 2012, does hereby determine and declare that the sum of Two million two hundred seven thousand three hundred seventy-three dollars (\$2,207,373.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: GENERAL ROAD FUND, INSURANCE FUND, ILLINOIS MUNICIPAL RETIREMENT FUND, SOCIAL SECURITY FUND, PERMANENT ROAD FUND AND EQUIPMENT AND BUILDING FUND for the year 2012.

SECTION 2: That the amount levied for each object and purpose shall be as follows:


SECTION 3: That the Town Clerk shall file with the County Clerk of said County of Cook on or before the last Tuesday of December, a duly certified copy of this ordinance.


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for the Maine Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

CERTIFICATE OF COMPLIANCE**



The taxing district=s aggregate levy did not exceed a 5% increase over the prior year=s extension. Therefore, a notice and a hearing were not necessary.


