## Agenda Item: Officials' Reports

Assessor Moylan Krey stated that the Tax Bills for the 1<sup>st</sup> installments were sent on January 20<sup>th</sup>. She added that the Tax Bills are available online and they are 55% of the previous year tax bill and they are due March 3<sup>rd</sup>.

Assessor Moylan Krey reported that the tentative opening with the County Assessor office for appeals will be on May 28<sup>th</sup> and will be open for 40 days. The Maine Township Assessor Office now is dealing with a lot of exemptions, questions on taxes, certificate of errors and they are serving over 200 people a day.

Assessor Moylan Krey stated that Cook County put out an abatement for surviving families of fallen police, military and rescue workers spouses who have died during their time of duty since 2012.

Clerk Gialamas added to his written report that t it was a rough month for the Clerk's office. Wiesia Tytko lost her father on December 19<sup>th</sup> and Cathy Fredericksen lost her father on January 25<sup>th</sup>. He expressed his condolences to his employees.

Trustee Sweeney stated that she attended the TOCC Trustee Division meeting which was focusing on helping on understanding Board and Robert's Rules procedures for more efficient meetings.

Trustee Carrabotta also expressed his condolences.

Trustee Carrabotta stated that he also attended the TOCC Trustee Division winter meeting in January. There was a great number of townships that showed up through representation and Maine Township was very well represented. He added that the programs were good and they learned a lot more about parliamentary procedures.

Trustee McKenzie stated that the TOCC conference was informative but she wished she learned a little bit more how to better run board meetings.

Trustee Jones agreed that the TOCC conference was informative and well attended. She wished everyone Happy and Healthy New Year.

Supervisor Morask extended her condolences to the Clerk's office staff and to Debbie Babich for losing her brother-in-law a few days ago.

Supervisor Morask thanked Attorney Krafthefer for supplying all the Elected Officials with the new Township Officials of Illinois Law & Duties Handbooks.

Supervisor Morask stated that we will have some changes in personnel since one person has resigned from her position. She added that we received a request for sponsoring a scholarship at Oakton Community College and added that it will be suggested to do it through Agency Funding. Supervisor Morask congratulated the whole staff of North Maine Fire Protection District for their 50<sup>th</sup> anniversary and added that John Bennet from OEM will be moving to the Director of OEM from acting director but with same part time hours. She and Administrator Berman have begun budget meetings with department heads.

Supervisor Morask informed everyone that Marie Dachniwsky, MaineStreamers Director is coordinating a Township Day on Saturday, June 20<sup>th</sup>. She added that the Park Ridge/Niles Crop Walk donated \$10,500.00 to the Maine Township Emergency Food Pantry.

## Ordinance No. 2020-1

## AN ORDINANCE abating a portion of the tax heretofore levied December 2019 for township and general assistance purposes of Maine Township, Cook County, Illinois.

WHEREAS, the Board of Trustees (the "Board") of Maine Township, Cook County, Illinois (The "District"), by an Ordinance adopted on the 16th day of December, 2019, Ordinance No. 2019-5 TAX LEVY ORDINANCE FOR MAINE TOWNSHIP ("2019" Levy Ordinance"); and

WHEREAS, duly certified copies of the 2019 Levy Ordinance were finlike in the office of the County Clerk of Cook County, Illinois (the "County Clerk"); and

WHEREAS, the Maine Township has funds arising from other sources, those funds being the reserve money in the bank as of December 31,2019 totaling \$8,119,122 in the Town Fund and \$2,089,200 in the General Assistance Fund, which may lawfully be used to pay operational expenses and therefore desires by Ordinance to direct the County Clerk to abate a portion of said levies;

WHEREAS, Township Code 60 ILCS 1-85-65 mandates that Township funds, excluding the Township's capital fund, shall not exceed an amount equal to or greater than 2.5 times the annual average expenditure of the previous 3 fiscal years;

WHEREAS, the Board has determined and does hereby determine that it is necessary and in the best interests of the Townships that a portion of the tases heretofore levied for the year 2018 for township and general assistance purposes be abated;

NOW, THEREFORE, Be It and It is Hereby Ordained by the Board of Trustees of Maine Township, Cook County, Illinois as follows:

Section 1. Incorporation of Preamble. The Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and corrected does incorporate them into this Ordinance by this reference.

Section 2. Abatement of Taxes. The taxes heretofore levied in the 2019 Levy Ordinance shall be abated as follows:

Section 3. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a verified copy hereof with the County Clerk, and it shall be the duty of the County Clerk to abate said taxes levied in the December 2019 Ordinance in accordance with the provisions hereof and as shown in Section 3 herein above.

Section 4. Effective Date. This Ordinance shall be in full force and effect forthwith upon its adoption.
