#### TAX LEVY ORDINANCE

## TOWNSHIP

#### ORDINANCE No. 2014-4

An ordinance levying taxes for all town purposes for Maine Township, Cook County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, Illinois, as follows:

SECTION 1: That the sum of five million three hundred and ninety one thousand nine hundred and fifty four (\$5,391,954) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necesary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as GENERAL TOWN FUND AND GENERAL ASSISTANCE FUND.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
