TAX LEVY ORDINANCE 2011

MAINE TOWNSHIP ROAD DISTRICT

ORDINANCE 2011 - RB 3

An ordinance levying taxes for all road purposes for the Maine Township Road District Cook County, Illinois, for the tax year 2011, collectable in 2012.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, as follows:

SECTION 1: That the Highway Commissioner of the Maine Township Road District on November 22, 2011 does hereby determine and declare that the sum of Two million one hundred twenty nine thousand and twenty five dollars (\$2,129,025.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:GENERAL ROAD FUND, PERMANENT ROAD FUND, EQUIPMENT AND BUILDING FUND, SOCIAL SECURITY FUND, INSURANCE FUND AND ILLINOIS MUNICIPAL RETIREMENT FUND for the year 2010.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
