

TAX LEVY ORDINANCE 2013

MAINE TOWNSHIP ROAD DISTRICT

ORDINANCE 2013 - RB 4

An ordinance levying taxes for all road purposes for the Maine Township Road District Cook County, Illinois, for the tax year 2013, collectable in 2014.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, as follows:

SECTION 1: That the Highway Commissioner of the Maine Township Road District on November 26, 2013 does hereby determine and declare that the sum of Two million two hundred ninety-two thousand three hundred fifty-seven dollars (\$2,292,357.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: GENERAL ROAD FUND, PERMANENT ROAD FUND, EQUIPMENT AND BUILDING FUND, SOCIAL SECURITY FUND, INSURANCE FUND AND ILLINOIS MUNICIPAL RETIREMENT FUND for the year 2013.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 3: That the Town Clerk shall file with the County Clerk of said County of Cook on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for the Maine Township Road District.




