ORDINANCE 2016-RB-6

An ordinance levying taxes for all road purposes for the Maine Township Road District

Cook County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of Maine Township, Cook County, as follows:

SECTION 1: That the Highway Commissioner of the Maine Township Road District on February 28, 2017 does hereby determine and declare that the sum of Two million five hundred fifty-one thousand nine hundred sixty-two dollars (\$2,551,962.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as: GENERAL ROAD FUND, PERMANENT ROAD FUND, EQUIPMENT AND BUILDING FUND, SOCIAL SECURITY FUND, INSURANCE FUND AND ILLINOIS MUNICIPAL RETIREMENT FUND for the year 2016.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
